

The “ISEE parificato” is a parameter for calculating the reduction in university fees, requesting a scholarship and accomodation from those who cannot calculate a specific ISEE for benefits for the right to education.



### DOCUMENTATION TO BE PRODUCED AT THE CAF

- ❖ Identity document of the student
- ❖ Student fiscal code issued by the Agenzia delle Entrate
- ❖ Any certificate of disability of the student recognized over 66% (medium, severe disability, non self-sufficient)
- ❖ Registration number at the University (if already registered) and degree course
- ❖ For the foreign student residing in Italy, DSU and ISEE certificate
- ❖ The amount of the scholarship received in the year 2020



### HOUSEHOLD

#### On the date of submission of the DSU

- Composition of the student's household on the date of presentation of the DSU reporting:
  - surname, name, date of birth and family relationship of all the subjects belonging to the household
  - the income produced by each member of the household (2020):
    - the income received by each member of the household, referring to the year 2020;
    - any other sums received by public administrations by way of welfare, social security and indemnity treatments;
    - the sums received or paid as support for children in the event of legal separation or divorce;
    - the real estate and the movable assets of each component (31/12/2020):
    - the real estate assets relating to buildings (if they are owned in Italy, it is necessary to present the land register to determine the value for the IMU; if they are owned abroad they are valued, only in the case of buildings, on the basis of the conventional value). The absence of assets must be expressly specified in the documentation.
    - If the household resides in a rented house, it is necessary to document the value of the annual rent provided for in the rental contract.
    - Movable assets, consisting of the balance to 31/12/2020 and the average balance for the year 2020 of:
  - Current accounts, deposits, passbooks, bank and/post office accounts held abroad and in Italy and the balance to 31/12/2020 for any other type of investment (securities, shares, life insurance, etc.).

The documentation described above, presented to the CAF for the issue of the certificate must be:

- issued by the competent authorities of the county where the income was generated;
- translated into Italian and legalized according to the regulations.
