SCHOLARSHIP AND ACCOMMODATION - CALL FOR APPLICATIONS A.Y. 2025/2026

Art. 1 – Eligible students

In accordance with the Ministers' Decree (D.P.C.M.) of April 9, 2001, students can access to benefits illustrated by the present call based on merit and income requirements indicated by articles 2 and 3, if during Academic year 2025/2026 they enroll to Courses at the following institutions, according to deadlines set by each Institution:

Sassari University - Università degli Studi di Sassari:

- Bachelor Courses (1st level) Corso di Laurea Triennale
- Single-cycle Courses (1st level) Corsi di laurea magistrale a ciclo unico;
- Master Courses (2nd level) Corsi di laurea magistrale;
- Specialization Schools Scuole di specializzazione (3rd level), except Specialization Schools related to the School of Medicine, regulated by Legislative Decree issued on August 4, 1999 numb. 368.
- PhD Courses Dottorati di ricerca (3rd level), activated based on Legislative Decree July 3rd, 1998 numb. 210, except students granted with scholarship based on regulations from D.M. of 30/04/99 numb. 224/99;

Sassari Academy of Fine Arts - Accademia di Belle Arti Sassari;

- Three-year Courses (1st level);
- Two-year Master Courses (2nd level);

State Conservatory of Music in Sassari - Conservatorio di Musica Sassari:

- Three-year Courses (1st level);
- Two-year Master Courses (2nd level);

Higher Institute of Religious Sciences - Istituto Superiore di Scienze Religiose - ISSR Sassari - Tempio Ampurias - Euromediterraneo:

- Three-year undergraduate Courses (1st level);
- Master Courses (2nd level);

Students who do not complete their enrolment by March 31, 2026, will lose their right to benefits and will be required to repay the Institution the amount corresponding to the value of any services received.

Access to benefits is not permitted for attendance at single courses, as such enrolment does not confer university student status. Students enrolling in the 2025/2026 academic year in the so-called "filter semester," according to Article 2, paragraph 1, of Ministerial Decree no. 418 of 30 May 2025, of the Single-Cycle Master's Degree courses in Medicine and Surgery (LM-41), in Dentistry and Dental Prosthetics (LM-46) and Veterinary Medicine (LM-42), activated by the University of Sassari, with the status of "student simultaneously enrolled" in the aforementioned course and the chosen similar course of study, are eligible to apply to the assignment of benefits, according to the procedures set out in the announcement.

Simultaneously enrolled students who will be attending the so-called "filter semester" at other universities will be eligible to apply for benefits following enrolment for the second semester of the 2025/2026 academic year, at the end of the "filter semester," in the Single-Cycle Master's Degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42), or a similar program (as required by Ministerial Decree no. 418/2025) offered by the University of Sassari, during an additional time window, according to the deadlines and procedures set out in the announcement.

To be eligible for the competition, these students must have submitted a scholarship application to the institution responsible for managing financial aid for students enrolled at the other university by the deadline established in the competition announcement of that institution.

The regulations contained in this announcement for the granting of benefits for students enrolled in the filter semester may be subject to change following the issuance of subsequent relevant regulatory provisions.

All requirements outlined in the announcement, including financial requirements (ISEE and ISPE for 2025), are those established for the 2025/2026 academic year and declared in the scholarship application submitted in the filter semester.

















Students not admitted:

students who already hold a degree of the same level as the one for which the scholarship is being requested (even if achieved abroad and not accepted in Italy) and students whose first year of enrollment is not the first year of registration.

In addition, are <u>not admitted</u> to the Call students who changed Course (due to transfer, change or interruption) and were the recipient, in the same academic year and for a course of the same level, of a scholarship.

Art. 2 - REQUIREMENTS BASED ON INCOME

Student's financial status is evaluated based on a certification of the family income status called ISEE (Indicatore della Situazione Economica Equivalente) according to the rules on the Rights to access to University Education set by the Decree of the President of the Council of Ministers of December 5th, 2013, numb. 159 and of the Directorial Decree of 28 February 2025, n. 180¹.

The ISEE certificate has to show, referred to the Fiscal Code of the students who is applying, the following statement "to be used to access to services and benefits made available to support the Right to University Education" and the Isee certificate mustn't have been issued before **January 2025.**

Another indicator called l'ISPE (Indicatore Situazione Patrimoniale Equivalente) is used to grant scholarships, which is an equivalent asset situation indicator calculated dividing ISP (Indicatore della Situazione Patrimoniale) by VSE (valore della scala di equivalenza): ISPE = ISP of the family unit ÷ equivalence scale coefficient.

ISEE certification data related to each student's fiscal code will be acquired by Ersu, prior consent, directly from INPS platform.

In order to be able to be granted any benefits, family income certification for each student mustn't exceed the following amounts:

ISEE to access to University Education Rights :	ISPE:
€ 27.948,60¹	€ 60.757,87 ¹

Exceeding even just one of the values above leads to be excluded from the lists of beneficiaries.

To take part to the present Call, the ISEE 2025 to access to University Education Rights must be submitted.

All students must indicate in the scholarship application the number of protocol of the ISEE certificate or of DSU (Single Substitute Statement) and give consent to acquire ISEE data from INPS platform.

It is important to check that "ISEE 2025 for University Education Rights" doesn't contain any anomalies, omissions or discrepancies.

Students who submit an <u>ordinary ISEE</u> or an <u>ISEE with omissions and discrepancies</u> will be excluded from the Call for Scholarship and Accommodation for the academic year 2025/2026.

<u>WARNING</u>: ISEE certificates 2025 non-compliant with Call requirements must be amended by and not after the end of the reconsideration procedures deadline (OCTOBER 22nd 2025), under penalty of exclusion.

Independent student status

Students are considered independent when both following criteria are applicable:

The student has lived for two years by him/herself in a household different from the family of origin prior to the
application submission and in a house that is not owned by a member of the family. Residence status in houses owned
by second degree of kinship relatives, both for direct and collateral lines, such as grandparents, siblings, etc are not
accepted to grant "independent student status", even if just a part equal to or higher than 50% of the house is owned

by one of the family members;

• Student's income based on regular work contracts declared for tax purposes for the two years prior to application with amount not lower than € 9.000,00 related to one-person family unit;

N.B. In case one or both of the latter criteria are not met, the calculation will be based on the family unit of origin and, as a consequence, the ISEE 2025 for the University Education rights will be integrated with ISEE from the family of origin. If no integrated ISEE is submitted, the student will be excluded from the ranking list.

















Even if the applicant student's parents are not cohabiting, they are considered to belong to the same house unit, except for the cases foreseen by law (D.P.C.M. numb. 159/13, art. 3, par. 2 for married parents and art. 7, par. 1 for unmarried parents).

The "Independent student status" can be applied also to married students, cohabiting and or separated.

In the case of married students, the income amount limit of $\leq 9.000,00^2$ can be reached by considering also the husband/wife income.

Students with requisites for "independent status" must submit a self-certification during the application process. This self-certification must be the same as what was declared during the DSU (Single Substitute Statement) submission.

If the above "independent student status" requirements are not met, students can anyway submit an ISEE declaration for university purposes if the following extra criteria are met:

- is orphan of both parents;
- belongs to a religious order or a shelter house;
- is convicted;
- is stateless.

PHD students

Only students enrolled to PhD courses can indicate a "restricted unit" (formed by the applicant, by his/her husband/wife, by children under 18 years of age as well as children over 18 who are still included into the family unit for tax purposes (IRPEF), but excluding any other additional family members).

Foreign students

While awaiting additional Ministry provisions to clarify application of DPCM 159/13, the calculation method for ISEE in case of foreign students whose family unit is resident abroad and also has income and or assets abroad, will be based on the **ISEE PARIFICATO.**

In order to achieve an ISEE PARIFICATO the student must rely on provisions indicated in Appendix A of the present Call.



N.B.: DEDUCTION OF SCHOLARSHIP RECEIVED IN 2023 - CU 2024:

When completing the application, students must also declare the scholarship received in the 2023 calendar year under "Economic Data." For scholarships awarded by E.R.S.U. Sassari, please refer to the 2024 CU, which can be downloaded from the Student Area personal page under "Certifications". For scholarships not awarded by E.R.S.U. Sassari, students must request a specific certification from the institution for the right to education that awarded the scholarship, which must be attached to the application.

E.R.S.U. Sassari will then subtract the scholarship amount paid in 2023 from their ISEE.

Students who did not receive any scholarship in the 2023 calendar year must declare a zero amount (€0.00).

Art. 3 – REQUIREMENTS BASED ON MERIT

First-year students

First-year students are students that enrolled for the first time in academic year 2025/2026 to one of the following Courses: Bachelor Degree Courses, Single-cycle Courses (1st level), Master Courses or two-year Specialization courses (2nd level) and Specialization or PhD Courses (3rd level).

Benefits are granted based on financial requisites. Merit requisite is evaluated ex-post (see art. 15). The student who had already received a scholarship during the first year but decides to interrupt a Course and enrol again to another Degree Course, cannot apply again during the same year, unless he/she gives back the scholarship amount received by the last deadline scheduled for reconsideration (October 22nd, 2025 for scholarships).

Students who don't complete the enrolment procedure by March 31st 2026 will lose eligibility for benefits and will have to give back to ERSU the amount corresponding to the value of services eventually granted.

Enrolment number transmitted after the deadline indicated in the Call, will not be accepted. Possible exceptions might be taken into account, only if the University provides specific explanations and if there are enough funds.

For students enrolled at the first year at Bachelor Degree Courses and Single-cycle Degree Courses (1st level), Master Courses or two-year Specialization courses (2nd level) the second instalment of the Scholarship is allocated when 20 credits are achieved, maximum by August 10, 2026 (art. 5, co. 2 e 3 of Ministry Decree D.M. numb. 1320 of 17/12/2021). Scholarship is suspended for first-year students enrolled at Bachelor and Single-cycle Courses and Master Courses who cannot achieve at least 20 credits by November 30th, of the solar year after the year of enrolment (art. 5, co 4 of Ministry Decree D.M. numb. 1320 of 17/12/2021).

Students who achieved 20 credits after August 10 and by November 30, 2026 are allowed to keep the first instalment received, as well as accommodation and access to the Canteen.

First- year students enrolled at 1st level Courses: Bachelor and Single-cycle Courses:

First- year students from 1st level Courses are students who are correctly enrolled to a Bachelor or Single-cycle Degree Course. Although students at the date of the Call opening (July 25th, 2025) haven't enrolled yet and haven't received an enrollment number, they can apply to receive a scholarship as "Not-enrolled first year students". In this case ERSU will assign a temporary enrollment number.

Once the student receives an enrollment number, this has to be transmitted to ERSU through an online procedure to certify that the registration has been completed.

This procedure does not apply to "Not-enrolled first year students" from Accademia di Belle Arti and Conservatorio di Musica as these two Institutions transmit to ERSU the enrollment lists.

<u>Second level first-year students: Master Course and two-year Specialization Course:</u> these are students who enrolled to a Master Course (University and Istituto Superiore di Scienze Religiose) or two-year Specialization Course (Accademia di Belle Arti and Conservatorio di Musica) and meet the following requirements:

a) 1st level Degree certificate

They can apply as "enrolled first year students" if they have an enrollment number or "not-enrolled first year students" if they haven't enrolled yet when they apply for scholarship;

b) At least 150 credits achieved by August 10, 2025 before the end of the last year of attendance (by the Supplementary Session). Students who achieved 150 credits by August 10, 2025 before the end of their last year of attendance, can apply as "not-enrolled first year students" when enrolling to a Master Course for the academic year 2025/2026. If they meet the financial requirements indicated by the call, they are going to be included in the ranking list of 2nd level first-year students with a pending status, while they are completing the enrollment procedure. These students will have to transmit their enrollment number to ERSU through an online procedure.

To reach 150 credits the bonus cannot be used.

















Students newly enrolled to Specialization Schools and PhD Courses (3rd level)

Students newly enrolled to third level Courses, based on rules foreseen by each training course regulation, can apply for benefits, except if they are attending beyond the course's prescribed length or if they repeated the first year. On the online application students have to declare if they were granted any other scholarship.

Students are excluded from benefits if the enrollment year is not equivalent to the first year of registration.

YEARS AFTER THE FIRST

The enrollment year is calculated taking into account the academic year in which the student enrolled for the first time to a Course, as explained in the following chart:

Level	Type of Course	Year of first enrollment
1st	Bachelor Degree Single-Cycle Degree	Academic year in which the student enrolled for the first time to any University located in Italy after having achieved the secondary school Diploma.
2nd	Master Course and two-year Specialization Course	Academic year in which the student enrolled for the first time to a Course in any University in Italy, after achieving the Bachelor Degree.
3rd	Specialization Schools and PhD Courses	Academic year in which the student enrolled for the first time to a Course in any University in Italy, after achieving a Master Degree or a Single-cycle Degree.

The minimum number of credits achieved by August the 10th 2026 to apply for the scholarship is specified as follows:

Study credits needed to access to benefits will be certified by each University the student belongs to. In order to meet the requisites based on merit for the Second level Master Degree Courses, also exceeding credits are taken into account, in addition to the 180 credits achieved through the Bachelor Degree when accepted by the Master Course (art. 6, comma 7 DPCM, April 9, 2001).

Incompatibility

The scholarship is **compatible** with student collaboration scholarships, scholarships for participation in international mobility

















programs (e.g., ERASMUS scholarships), and/or other benefits provided by other public and private institutions/entities for purposes other than supporting the right to education.

Students eligible for multiple forms of assistance are required to exercise this option (Article 24 of Regional Law 37/87).



STUDENTS ENROLLED IN MULTIPLE COURSES

Without prejudice to the provisions of current legislation (Ministerial Decree 1320/2021, Article 6, final paragraph, Law No. 33/2022, Article 3, and Ministerial Decree 930/2022, Article 7), students who simultaneously enrol in two courses of study will receive the benefits provided by this announcement for attendance at only one course, as indicated in the application. Students already enrolled in a program in subsequent years may not use their second enrollment as a reference for the purposes of receiving the right to education benefit.

Students enrolled, pursuant to current legislation, in multiple programs simultaneously are permitted to obtain and maintain the scholarship, increased by 20%.

Without prejudice to the provisions of paragraph 1 of this article, students with one or more already established academic careers must submit their scholarship application using the oldest enrolment as a reference. To benefit from the increase provided for dual enrollment, they must maintain the merit requirements for both programs.

The increase referred to in the first sentence is not due if the student no longer meets the scholarship requirements for the program to which the aforementioned increase was associated.

The regulations contained in this announcement for the granting of benefits in the event of double enrollment may be subject to changes following the possible issuance of subsequent regulatory provisions on the matter.



FEMALE STUDENTS ENROLLED TO S.T.E.M. (SCIENCE, TECHNOLOGY, ENGINEERING AND MATHEMATICS) COURSES

An additional amount of 20% on the scholarship for female students enrolled at S.T.E.M. (science, technology, engineering and mathematics) Courses is foreseen. Such additional amount cannot be aggregated to the increase that applies to financially disadvantaged students with ISEE value lower or equal to half of the maximum reference value.

CREDIT NOT RECOGNIZED FOR SCHOLARSHIP PURPOSES

For all degree programs, credits related to the following will not be considered:

- partially validated exams, for which additional credits are required for the final grade;
- exam modules for which the final exam has not been passed yet;
- training internships not yet completed as of August 10, 2025;
- integrated courses if not all required modules have been taken;
- additional exams, not counting toward the degree;
- · credits earned in individual courses;
- credits earned in departmental entrance tests;
- Exams validated from a previous career following withdrawal from studies or loss of status and re-enrollment in the first year of the new course; the exclusion will be valid for the year(s) following the validation and for a number of career years equal to those validated. (For example: exams validated from the previous career relating to the first year of the current career will not be taken into consideration for participation in the competition for the second year of the career; exams validated from the previous career relating to the first and second years of the current career will not be taken into consideration for participation in the competition for the second and third years respectively, and so on.) This exclusion does not apply to training credits earned in the new career upon completion of a partially validated exam;
- For students participating in international mobility programs (ERASMUS or similar), only credits communicated by August 10, 2025, by the foreign university certifying that they have passed the exams at the University of Sassari and validated by the relevant department's resolution will be considered valid, even if they require additional credits. Pending validation, the student will be placed on the ranking list as "conditionally admitted."

















"BONUS"

In order to achieve merit requisites, students can use in addition to credits effectively achieved also a "bonus" for each year of attendance, based on following criteria:

In the case of a student who uses only part of the bonus, the part of bonus not used during the year to which the bonus was related to can be used in subsequent years. This is applied also for bonus related to previous careers.

Such "bonus" cannot be used by first-year students to achieve the 20 credits and to achieve the 150 credits needed to participate to the Call for students newly enrolled to 2nd level Courses.

If a student only partially used the bonus during the Bachelor Course, then for the 2nd level Master Course/Two-year Specialization Course **only** the remaining part of the bonus can be used to calculate merit requisites.

If students enrolled to subsequent years at 2nd level Courses have never used BONUS credits, they will be granted the whole 15 credit Bonus.

N.B. The BONUS can be used **ONLY** to achieve the minimum merit requisites as indicated by the Call. The ranking lists will be formed based on credits effectively achieved by students, so only to calculate the merit threshold but it can't be taken into consideration when calculating the score for the ranking list.

Art. 4 – Definition of change, transfer, shortening and interruption of Courses

In case of change of Course, shortening or transfer to other Universities, in order to be admitted and be included on the ranking list, the student's merit is calculated based on years of attendance starting from the year of first enrollment seen as the year when the student enrolled for the first time to the Course prior to the change/ transfer/shortening.

Students with Bachelor Degree that enroll to a Single-cycle Course will be allowed to access to benefits only starting from the 4th year of the Single-cycle Course. ERSU will consider students at the 4th year, without taking into account the year indicated by the University. In case of change of Course or transfer only the credits accepted by the new Course to which the students enrolled will be considered for the merit for the academic year 2025/2026; credits will be calculated based on the Department resolution, while awaiting for validation the student will be indicated in the ranking list as pending. (i.e. for what concerns the scholarship, if a student changes from the 3rd year of the Dentistry Course to the 2nd year of Medicine, he will be considered as registered to the 3rd year at the Medicine Course: thus he/she will have to show that he has achieved in the new Course a total of 80 credits. Therefore, if after changing to the new Course the University Department validates less than 80 credits, the student will be excluded from any scholarship or other benefits that might be granted.)

In the event of enrollment following withdrawal from studies or loss of status and re-enrollment in the first year of the new program, the year of new enrollment will be considered. However, for the purposes of the ERSU benefits under this

















announcement, credits earned in the previous academic year cannot be declared for the year(s) following validation and for a number of academic years equal to those validated. (For example: - validated exams from the previous academic year relating to the first year of the current academic year will not be considered for participation in the competition for the second academic year; - validated exams from the previous academic year relating to the first and second years of the current academic year will not be considered for participation in the competition for the second and third years, respectively, and so on.) This exclusion does not apply to academic credits earned in the new academic year upon completion of a partially validated exam.

The applicant student may compete as a newly enrolled student, provided they have not already benefited from the benefits for the same academic year.

Students who have ongoing procedures of Course change, transfer or want to interrupt a Course, are asked to promptly inform ERSU.

Art. 5 - Scholarship Conversion

a) Converting a scholarship from Bachelor Course to a Master Course or two-year specialization Course (2nd level)

Students who have been granted a scholarship _for the last semester (1st year beyond the regular timeframe) of the year 2025/2026 and once achieved the Bachelor Degree might enroll to the 2nd level Master Course during the same year; in this case the student's scholarship can be converted into a scholarship for students newly enrolled at 2nd level Courses; this must be done within maximum 15 days after the Degree exam.

Scholarship or accommodation will be granted only after evaluation both of student's financial requisites and funds/accommodation potentially available.

Benefits will be granted based on the final ranking list for scholarships for **first year of enrollment to 2nd level Master Courses.** In case of lack of funds by ERSU, the students will be indicated on the ranking list as "eligible but non-beneficiary" ("Idoneo non beneficiario").

Students' Accommodations: if the student who has been granted an accommodation becomes a supplementary year student, so he/she is attending beyond the regular timeframe, he/she the benefit revoked and as soon as he gets the Degree he/she will have to inform ERSU and go away from the student residence.

b) Converting the scholarship from Bachelor Course to Single-cycle Course

Students enrolled at the 3rd year who is granted with a scholarship for the last semester (1st year supplementary Course) and is **allowed to change** to a Single-cycle Course can ask, as soon as he/she receives the specific documents, that the scholarship received for the semester is converted into a scholarship for the 4th year of the Course to which he/she has been admitted.

In order to achieve such a conversion, apart from submitting the income documents, the students will have to submit specific documents showing that for credits achieved by August 10, 2025 a sufficient number has been converted in order to be compliant with merit requirements for the scholarship and/or accommodation for the new Course.

Acceptance of applications for scholarship conversion are subjected to availability of funds allocated for this purpose. If income requisites from art. 2 and/or the aforementioned merit requirements are not met, the student neither will achieve a scholarship conversion nor be granted accommodation in the students' residences.

Art. 6 Integration for extra semester a.k.a "Graduation Award"

Scholarship-winning students in their final year of regular studies, who earn their bachelor's or master's degree within the timeframe established by their respective academic programs, will receive a scholarship supplement equal to half the amount received in the final year of their studies.

<u>Only and exclusively</u> students "beneficiary" of a scholarship during the year of graduation can apply to the Graduation Award.

The application must be submitted via online procedure after the Degree exam.

In case of limited funding the award will be allocated based on the date of graduation:

- Summer exams session;
- 2. Autumn exams session;
- 3. Extra session.

Student beneficiary of a scholarship in academic year 2025/2026 and regularly enrolled during the same year who might achieve a degree before the end of what is considered of the normal duration of the Course according to the law

















(which is: third year of attendance for Bachelor Courses and Second year for Master Courses, etc), will be granted with the whole scholarship and will be granted with a Degree Award based on rules foreseen by the present article. While instead the student beneficiary of a scholarship for academic year 2025/2026 achieves the Degree before the legal Course duration and by the extra session of year 2024/2025, she/he will receive the first installment for the first semester, but not the second installment.

Art. 7 - Duration and benefits granting

Based on art. 3, par. 4 of the DPCM 2001 students can access to benefits foreseen by the present Call only for the first Degree exam achieved for each study level, for the maximum period of time indicated below, which is calculated starting from the first year of enrollment:

- Bachelor Course (1st level): for a period of seven semesters, plus an extra semester only for what concerns the accommodation;
- **Single-cycle Course:** for a period of time corresponding to duration foreseen by training regulations for each Course plus a semester and, an additional extra semester just for the accommodation;
- Master's Degree or two-year specialization (2nd level): for a period of five semesters and an extra semester only for accommodation;
- Specialization Courses and PhD Courses (3rd level): for a period corresponding to the duration foreseen by training regulations for each Course, starting from the year of first enrollment.

Duration of benefits for students attending Accademia di Belle Arti and Conservatorio di musica is equivalent to the duration foreseen for students enrolled at Sassari University.

Degrees based on the former Italian University system (prior to 1999) are considered equivalent to the Master Courses (both 1st level Single-cycle Courses and 2nd level Master Courses) and can be taken into consideration only for students enrolled to 3rd level Specialization or PhD Courses to access to benefits either for scholarship and/or accommodation.

Should be noted that benefits can be granted only once for each study level, regardless of the Institution (Conservatorio, Accademia, University and ISSR) that validated the credits.

Special cases

In case of interruption of studies due to severe and prolonged health problems that have to be specifically certified or for female students for each year when a child was born, the period of interruption, **if formally certified by the University**, is not considered while evaluating the career and the merit.

Art. 8 - Criteria for the formulation of rankings and publication.

Ranking of First-Year Students

For first-year students, the rankings lists will be formulated in ascending order based on the ISEE and divided as follows:

- 1. Bachelor and Single-cycle Courses (1st level);
- 2. Master's Courses/two-year specialization courses (2nd level);
- 3. Specialization and PhD Courses (3rd level);

"Filter Semester" Rankings

Students enrolled in the filter semester will be included in the General "Accommodation" Rankings (provisional and final) with the wording: "ELIGIBLE with SUSPENDED" status.

The suspension will be lifted following enrollment at the University of Sassari, following placement in a suitable position in the national ranking list according to Article 7 of the Decree of the Minister of Universities and Research, No. 418 of May 30, 2025.

Rankings of students enrolled after the conclusion of the "filter semester"

After the deadline for receiving further applications for benefits in the additional time window, following the publication of the national ranking list pursuant to Article 7 of Decree No. 418 of the Minister of University and Research of May 30, 2025, the "Second Semester Benefits" ranking lists will be drawn up.

















The publication date of the ranking lists may be postponed, following approval of the national ranking list.

- a) Ranking Lists for "Second Semester Benefits" Scholarship
- The ranking for scholarship will consist of **students already included in the general ranking**, suspended because they were enrolled in the "filter semester," who will be enrolled in the degree programs at the University of Sassari, and **students who applied during the additional time window**, who were enrolled in the "filter semester" at other Italian universities and will be enrolled at the University of Sassari in the second semester **at** Single-Cycle Degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) (as they were ranked highly in the national ranking), **or in the second semester of the related program** referred to in Article 8 of Ministerial Decree No. 418/2025 (as they were not ranked highly in the national ranking).

Students included in the aforementioned ranking after submitting their application by the standard deadline will be excluded from the "Second Semester Benefits" ranking if, after completing the filter semester, they have not enrolled for the second semester in a degree program at the University of Sassari.

b) "Second Semester Benefits": Rankings for Accommodation

The ranking list for the allocation of **accommodation** will consist of students already included in the general ranking, enrolled in the "filter semester," but not eligible for benefits due to insufficient available accommodation spaces; students who applied through the additional time window, who were enrolled in the "filter semester" at other Italian universities, and who will be enrolled at the University of Sassari in the second semester of the Single-Cycle Degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) (as they were ranked highly in the national ranking list), **or in the second semester of the related program** referred to in Article 8 of Ministerial Decree No. 418/2025 (as they were not ranked highly in the national ranking list).

Students included in the ranking after submitting their application by the standard deadline will be excluded from the "Second Semester Benefits" ranking if, after completing the filter semester, they have not enrolled for the second semester in a degree program at the University of Sassari.

Ranking for students beyond the first year

For students enrolled in years following the first in all degree programs, separate rankings will be prepared, <u>divided by year of study and degree program</u>, giving priority to the number of credits achieved and subsequently to the arithmetic average of the grades obtained.

In the event of equal ranking, the ranking position is determined by the ISEE.

For students enrolled in years following the first in Specialization and PhD Courses, a single ranking will be formulated in ascending order based on the ISEE.

Publication of rankings

The ranking lists will be published on the website <u>www.ersusassari.it</u> and in the students' personal area.

Students will be able to check their data and ranking position by accessing the online page with their credentials.

These methods of publication shall be considered, for all intents and purposes, as official notification to the participants.

In the final rankings, students will be considered as:

- Beneficiaries: when the student meets the requirements set out in the call for application and is entitled to the benefits;
- <u>Eligible non-beneficiaries</u>: when the student meets the requirements set out in the call for applications but is unable to receive the benefits due to insufficient available resources;
- Excluded: when the student does not meet the requirements set out in the call for applications or did not submit the application within the deadlines and according to the procedures specified in the call.

Admitted with Reservation

When the student is in a pending situation that requires further investigation by the offices.

The reasons for which the student may be granted conditional admission are as follows:

- Awaiting validation of Erasmus exams and similar (art. 3);
- Transfer/change of course awaiting validation of exams;
- Student not yet enrolled;
- Student undergoing assessment;
- Awaiting integration of consular and/or income documentation for international students.
- "ELIGIBLE with SUSPENDED status" (with the following wording in the ranking: "student enrolled in the filter semester suspended outcome"): Students enrolled in the "filter semester" who meet the requirements set out in the call for applications will be able to benefit from housing and dining services at discounted rates during the filter semester.

Students admitted conditionally, with the exception of students undergoing assessment and students in the filter semester, will receive advance payment of housing and dining services, while the scholarship will be suspended. The services must be returned if the outcome of the assessment results in the revocation of the benefit. Furthermore, all students with a conditional admission code must submit additional documentation to verify their admission requirements by the following dates, under penalty of revocation of the benefit:

- **January 15, 2026**: deadline for submitting consular and income documentation for foreign students admitted conditionally who requested it by December 31, 2025.
- **31 March 2026:** Students provisionally admitted awaiting validation of Erasmus exams and similar (see art. 3, p. 7) and awaiting validation of exams for transfer/change of course;
- **31 March 2026:** first-year students at first and second level courses, communication of enrollment number. Judicial and administrative appeals provided for by law may be lodged against the final rankings.

Article 9 - Allocation and Distribution of Scholarships

The allocation for the 2025/2026 academic year is determined by the amounts budgeted, adjusted on the basis of the provisions of Regional Council Resolution No. 38-14 of July 16, 2025, approving the Guidelines for Calls for Scholarships and Support Actions for Deserving Students lacking financial means, including Students with Disabilities - Academic Year 2025/2026, and in accordance with the criteria established therein. This resolution provides for the use of resources deriving from the regional tax for the right to education, regional resources based on the financial position SC08.6644 of the Regional Council of 00 11.02.02, and subsequently EU resources from the Sardinian Regional Development Fund (PR) ESF+ 2021-2027, and, in even greater order, the regional resources referred to in Article 16, paragraph 22, of Regional Law No. 13 of 2024, as amended by Regional Law No. 12 of 2025, Article 3, paragraph 7, letter b); the savings relating to the regional resources allocated for extra grants due to failure to assign housing services pursuant to Resolution No. 41/20 of October 23, 2024; State funding relating to any extra resources from the FIS from previous years and the 2025 State Supplementary Fund, and, finally, the resources deriving from restricted administrative surpluses and other resources of the Authority.

As foreseen by the Sardinian Regional Council through Resolution No. 38-14 of 16/07/2025, ERSU has allocated a part of the amount equivalent to € 250.000,00 for the year 2025/2026, which could be further increased based on future needs, for first-year students from Single-Cycle Courses in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42).

Scholarship amounts for the academic year 2025/2026, according to the type of student, have been updated in accordance with

















paragraph 2 of Article 3 of Ministerial Decree No. 1320 of 17/12/2021, and are therefore defined as follows:

- € 7.072,10 for non-resident students;
- € 4.132,85 for commuter students;
- € 2.850,26 for resident students.

The scholarship amounts for the academic year 2025/2026 will be increased as follows:

- a 15% increase for the most economically disadvantaged students with an ISEE indicator less than or equal to half of the maximum reference limit;
- a 40% increase for students with disabilities as defined in Article 1, paragraph 1, letter g) of D.M. no. 1320 of 17.12.2021, with a recognized disability greater than 80%;
- a 20% increase for students with disabilities as defined in Article 1, paragraph 1, letter g) of D.M. no. 1320 of 17.12.2021, with a recognized disability between 66% and 80%;
- a 20% increase for female students enrolled in S.T.E.M. (Science, Technology, Engineering, and Mathematics) degree programs. This increase cannot be combined with the increase provided for economically disadvantaged students with an ISEE indicator less than or equal to half of the maximum reference limit;
- a 20% increase for students enrolled in more than one degree program, provided they meet and maintain the merit requirements set out in D.M. n. 1320 of 17.12.2021 for the entire duration of the courses;
- "Independent" students will receive the scholarship amount granted to "non-resident" students if they use paid accommodation that can be documented.

The annual reduction corresponding to the months of actual provision of housing service is equal to €2.392,15.

The reduction amounts to € 956,86 per daily meal on an annual basis, based on the actual number of days the catering service is provided (an average of 275 days per year). In agreement with the elected student representatives, an additional daily meal deduction is applied for non-resident students and one daily meal deduction for commuting students. If ERSU cannot ensure access to free meals, an amount equivalent to the meal from the Canteen will be assigned.

The reductions applied to the accommodation and catering services must ensure increases of €900 for 'non-resident students, €700 for "commuter" students, and €500 for "resident" students.

Payment of scholarship instalments

The scholarship amount due, net of any reductions for catering and housing services, is paid according to the following terms:

STUDENTS ENROLLED IN THE FIRST YEAR OF THE BACHELOR AND AT SINGLE-CYCLE COURSES:

- **10 November 2025** Payment of the first installment, equal to 20% of the total, to students listed in the final scholarship ranking, provided they are regularly enrolled in their respective Universities;
- **31 December 2025** Payment of the first installment, equal to 30% of the total, to students listed in the final scholarship ranking, provided they are regularly enrolled in their respective Universities;
- **30 June, 2026** payment of second installment corresponding to the remaining 50%, if 20 credits have been achieved by August 10, 2026.

STUDENTS ENROLLED TO THE FIRST YEAR AT MASTER COURSES/ TWO-YEAR SPECIALIZATION COURSES

- **31 December, 2025** payment for first installment, corresponding to 50% of the total amount, to students on the final ranking list for scholarship as long as they are regularly enrolled their respective Universities.
- **30 June 2026** payment for second installment, corresponding to 50% of the total, if 20 credits have been achieved by August 10, 2026.

STUDENTS ENROLLED TO SUBSEQUENT YEARS:

- **31 December 2025** payment for first installment, corresponding to 50% of the total amount, to students on the final ranking list as long as they are regularly enrolled in their respective Universities;
- 30 June 2026 payment for second installment, corresponding to 50% of the total.

The quota reserved for students with disabilities is deducted from the above allocation based on the percentage weight of

















applications from the previous year. The remaining funding is allocated 30% to first-year students and 70% to subsequent years.

The amount to be allocated to students who enroll for the first time is allocated for the 1st, 2nd and 3rd level Courses, based on the percentage weight of eligible students in the final ranking list.

Amounts for students enrolled to the subsequent years are further allocated based on each year of Course, based on the percentage weight of eligible students in the final ranking list so as to ensure one scholarship for each year of attendance. Allocated funds might be increased in case of new resources and they will be distributed based on criteria indicated in this article. Ranking list progression will take place only if additional funding is allocated, while no ranking list progression will take place in case of withdrawal and revocation of students occurred during the same year after the publication of final ranking lists.

The budget to finance scholarship is equivalent to an amount of € 30.328.710,00 and is based on the following resources:

- Yield of regional taxation;
- Regional Funds
- PR SARDEGNA FSE+2021-2027;
- Advance payments from PNRR Regione Sardegna, ex paragraph 22 art. 16 of Regional Law (LR) No. 13, 2024, modified by LR No. 12 of 2025, art. 3, par. 7, lett.b);
- Funding related to regional resources allocated to supplement students who were not granted accommodation, based on Resolution of the Sardinian Region, numb. 41/20 of23/10/2024;
- State Integrative Funds (FIS) from previous years;
- State Integrative Funds Advanced payment 2025;
- Scholarship allocated from the Sardinian Region;
- Scholarships from available exceeding earmarked resources;
- Scholarships from limited exceeding earmarked resources;
- Exceeding resources from revoked scholarships from previous years.

















The amount reserved to disable students is equivalent to € € 776.501,65 while the remaining funds equal to € 29.552.208,32 are divided as follows:

Such amounts will be promptly modified in case of official communication regarding additional resources to be used for this purpose.

Scholarships allocated through regional resources (Pos.fin. SC08.6644 of Resolution of the Regional Council 00.11.02.02) can be reported in overbooking on funds from Sardinia Regional Programme FSE+ 2021-2027 - Priority 2 "Education, training and skills"- Specific objective ESO4.6 f) - Field of intervention 150 "Support for tertiary education" excluded facilities) through the intervention: "Scholarships and support actions in favour of capable and deserving students lacking financial means and promotion of merit among students, including students with disabilities academic year 2025/2026"; therefore the Entities have to be compliant with rules related to the use of Sardinia Regional Programme funds FSE+ 2021-2027, such as, among other rules, the obligation in terms of communication including use of mandatory logos as well as reporting in the Call description the following paragraph: "Regional resources related to scholarship granting allocated through ERSU to beneficiaries can be reported in overbooking on funds from Sardinia Regional Programme FSE+ 2021-2027 - Priority 2 "Education, training and skills"- Specific objective ESO4.6 f) — Area of intervention 150: "Support for tertiary education" excluded facilities) as indicated by Sardinian Council Resolution No. 38/14 of 16.07.2025".

It is specified that all forms of communication must ensure accessibility for people with disabilities and that questionnaires and surveys will be provided to verify that the interventions also reach people with disabilities.

Art. 10 – Scholarship amounts

Scholarships are granted both in the form of money payment (monetary) and services to be used by the end of the academic year. However, the amount of the monetary scholarships will not change, even if the student doesn't access to the Canteen, in the following way

- *€ 18.632,40: 2/3 ISEE;
- *€ 13.974,30: 50% ISEE;
- The maximum amount of the monetary scholarship is allocated to students whose ISEE is equivalent or lower than € 18.632,40 (which corresponds to 2/3 of the limit value indicated in Income Requisites). In case of higher ISEE, the monetary scholarship is proportionally reduced until the half of the amount. ERSU reserves the right to adjust the amounts in case of changes related to law or regulations;
- The scholarship amount for beneficiaries of a scholarship for a six-month period will be equivalent to the 50% of amounts indicated in the table.
- Students who submit an application to access to accommodations and to get a scholarship and afterwards withdraws
 from accommodation, will have to submit this request by the deadline set up for the procedures of reconsideration
 for accommodation. If the students withdraw after this term, the amount of the scholarship will be the same as the
 one indicated in the final ranking list and it will not be modified.
- Students beneficiaries of a scholarship who are granted an accommodation during the year, will have an amount deduced from the scholarship equivalent to € 199,35 per month, regardless the type of accommodation (room) that had been assigned. If a and then is assigned accommodation due to the ranking list progression but he/she does not accept it immediately. No deduction will be applied to students who did not initially get accommodation (students who were eligible on the ranking list but not beneficiary) if they don't accept it when they are offered one at the moment of the ranking list progression. N.B. Deduction of the amount to be paid for accommodation will instead be applied if the student doesn't accept the accommodation after the ranking list progression.
- Students eligible for scholarship who did not receive it due to lack of funding can access to the Canteen without any charge.
- Non-resident students can get two meals a day for a maximum of 275 meals during the whole academic year.
- Commuting students can get one meal a day for a maximum of 138 meals during the whole academic year.
- Students with scholarship and eligible on the ranking list (but not Resident beneficiaries) can get one meal a day completely free from charge.
- When no Canteen is available for local branches, an amount of € 720,92 (equivalent to the amount deduced for the meals) will be paid to non-resident students beneficiaries of a scholarship and an amount of € 360,46 to commuting students who received a scholarship (equivalent to the amount deduced for the meals).
- In the case ERSU cannot provide free meals, the corresponding amount will be converted into a monetary amount (Resolution of the Sardinian Council No. 38/14 DEL 16.07.2025).

The discounted Canteen rate for students enrolled in the so-called "filter semester," consisting of at least 51% in-person teaching activities, for the Single-cycle degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) in Sassari, is €2,10.

For students who become scholarship recipients after the so-called "filter semester," following enrollment in one of the degree programs at the University of Sassari, the amount of the canteen service paid, at a discounted rate, for use of the canteen service during that semester, will be deducted from the value of the canteen service deducted from the assigned scholarship.

Discounted accommodation rates

The monthly fees for students with accommodation and for students enrolled in the so-called "filter semester," consisting of at least 51% in-person teaching activities, for the single-cycle degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) in Sassari are as follows:

Single room fee: €82.00Double room fee: €61.34

For students who become scholarship recipients after the so-called "filter semester," following enrollment in one of the University of Sassari's degree programs, the amount of the accommodation fees already paid for the use of the accommodation service during the semester filter will be withheld by ERSU from the value of the accommodation service deducted from the assigned scholarship.

Article 11 - Application Procedures and Deadline

Applications to participate in the competition, including those from students enrolling in the filter semester at the University of Sassari (so-called "concurrently enrolled students"), must be submitted exclusively online by connecting to the University's website: www.ersusassari.it "Student Area" from July 25, 2025, to 1:00 p.m. on September 8, 2025

Students enrolling in the "filter semester" at the University of Sassari

Students enrolling in the "filter" semester in the Single-cycle degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) at the University of Sassari must submit an application for benefits to the ERSU Sassari according to the procedures, requirements, and deadlines set forth in the call for applications. During the filter semester, which consists of at least 51% in-person teaching activities, students with the status of "concurrently enrolled student" may benefit from the benefits for the protection of the right to education relating to accommodation and meals according to the requirements, procedures, and discounted rates set forth in these guidelines and in the call for applications for scholarships and accommodation services for the 2025/2026 academic year.

Any applications for benefit allocation submitted during the additional application window by students enrolled in the filter semester at the University of Sassari, who enroll in the degree courses in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46) and Veterinary Medicine (LM-42) at the University of Sassari or in related courses activated by the University of Sassari, after the conclusion of the so-called "Filter Semester", who have not submitted the relevant application by the deadlines indicated in the previous point, will not be accepted.

Students who had enrolled in the "filter semester" at other Italian universities and then enroll at the University of Sassari in:

- a) the second semester of the Single-cycle degree programs in Medicine and Surgery (LM-41), Dentistry and Dental Prosthetics (LM-46), and Veterinary Medicine (LM-42) (as they were ranked highly in the national ranking);
- b) the second semester of the related program referred to in Article 8 of Ministerial Decree No. 418/2025 (as they were not ranked highly in the national ranking);

















must submit an application for an additional scholarship to the ERSU Sassari by the deadline set out in the call for applications.

In order to apply, the student will have to access to the ERSU website **exclusively through SPID or Electronic Identity Card (CIE) credentials** in compliance with the Legislative Decree 16th July 2020, numb. 76 indicating urgent measures for digital simplification and innovation, converted into Law numb. 120 of September 11, 2020

During the application and until TRANSMISSION, it will be possible to modify the online application so as to allow students to get mandatory data and documents. Once this step is achieved, it is not requested to submit a signed application form, instead additional documents in PDF format can be submitted in order to facilitate the ranking process. This procedure will allow the student to finalize the submission that must be
TRANSMITTED">TRANSMITTED to ERSU by and not later than 1 pm on September 8 2025, under penalty of exclusion.

Art. 12 - Requests for review of the rankings and Declaration of Non-resident Status

On September 22, 2025, the provisional housing rankings will be published, and on October 14, 2025, the provisional scholarship rankings will be published on the website www.ersusassari.it in the 'RANKINGS' section, in accordance with current privacy regulations. Each student can check their detailed position by accessing their personal area. Students are required to verify the accuracy of the data reported in the provisional rankings and to submit a request for review to correct any material errors, inaccuracies, or updates (such as obtaining another scholarship, transferring to another university, withdrawal from studies, failure to enroll, graduation by the final session of the 2024/2025 academic year, etc.), as further specified below:

- Requests for review of provisional housing rankings: From September 22, 2025, the date of publication of the
 provisional housing rankings, until September 28, 2025, it is possible to submit a request for review to correct and/or
 supplement the self-certifications submitted by students who applied for the scholarship and accommodation. It is
 also possible to withdraw from the accommodation, modifying what was stated in the submitted application, no later
 than September 28, 2025;
- Requests for review of provisional scholarship rankings: From October 14, 2025, the date of publication of the provisional scholarship rankings, until 1:00 PM on October 22, 2025, it is possible to submit an online request for review to correct and/or supplement the self-certifications submitted by students who applied, limited exclusively to the awarding of the scholarship.
 - March 31, 2026: Deadline for the online procedure to enter the enrollment number for those enrolled in the Bachelor's and Single-cycle master's degree Courses (1st level);
- <u>Declaration of Non-resident Status:</u> From December 1, 2025, and no later than 1:00 PM on March 31, 2026: Submission of the Declaration of Non-resident Status (see Art. 16) through the online procedure, under penalty of reclassification from "Non-resident" to 'Commuter,' with the consequent adjustment of the scholarship amount.

Any benefits unduly received, due to failure to report and correct inaccuracies, will be revoked, and the amounts received, along with the value of the services used, must be repaid.

Art. 13 - Payment Methods

The payment of the scholarship will be made, **subject to the actual transfer of funds by the Region of Sardinia**, net of any deductions for catering and housing services, and will be paid according to the following procedures:

STUDENTS ENROLLED IN THE FIRST YEAR OF BACHELOR'S AND SINGLE-CYCLE MASTER'S DEGREE PROGRAMMES:

- **November 10, 2025**: payment of the first installment, equal to 20% of the total amount, to students included in the final scholarship ranking, provided they are regularly enrolled at their respective universities;
- **December 31, 2025:** payment of the first installment, equal to 30% of the total amount, to students included in the final scholarship ranking, provided they are regularly enrolled at their respective universities;
- **June 30, 2026**: payment of the second installment, equal to the remaining 50% of the total amount, upon attainment of 20 credits, provided they are achieved by **August 10, 2026**.

STUDENTS ENROLLED IN THE FIRST YEAR OF A MASTER'S DEGREE / TWO-YEAR SPECIALIZATION PROGRAMME

- **December 31, 2025:** payment of the first installment, equal to 50% of the total amount, to students included in the final scholarship ranking, provided they are regularly enrolled at their respective universities;
- June 30, 2026: payment of the second installment, equal to the remaining 50% of the total amount, upon attainment of 20 credits, provided they are achieved by August 10, 2026.

STUDENTS ENROLLED IN SUBSEQUENT YEARS/ STUDENTS ENROLLED IN YEARS BEYOND THE FIRST:

- **December 31, 2025:** payment of the first installment, equal to 50% of the total amount, to students included in the final scholarship ranking, provided they are duly enrolled at their respective universities;
- June 30, 2026: payment of the second installment, equal to the remaining 50% of the total amount.

 The scholarship payment will be made through a bank transfer to an account held solely or jointly by the student (postal

















savings books and similar are excluded).

Students must provide the IBAN code for the payment and their certified email address (PEC) when completing the online application.

If the IBAN code provided by the student is incorrect, or the account is registered to a person other than the student beneficiary, the Institution will not be held responsible for any delays in payment, and any penalty applied by the Treasury for reissuing the payment order will be charged to the student. Students who experience difficulties in receiving funds issued in their name must promptly notify in writing via email to dirstudio@ersusassari.it.

First- and Second-Level First-Year Students:

For students enrolled in the first year of Bachelor's Degree programs and Single-cycle Courses (1st level), as well as Master's degree and two-year specialization programs (2nd level), the second installment of the scholarship will be paid upon achievement of 20 credits, provided they are validated by **August 10, 2026** (art. 5, paragraphs 2 and 3 of Ministerial Decree no. 1320 dated 17/12/2021).

The scholarship will be revoked for students enrolled in the first year of Bachelor, Single-cycle, and Master Courses who have not earned at least 20 credits by November 30 of the calendar year following their enrollment (art. 5, paragraph 4, of Ministerial Decree no. 1320 dated 17/12/2021).

Students who earn the 20 credits after August 10 but by **November 30, 2026**, are entitled to retain the first installment they have received.

The academic credits reported by the student, valid for the purpose of granting the benefit, will be certified by their respective universities.

<u>First-year students of third-level programs:</u> For students enrolled in the first year of Specialization schools and PhD Courses, first installment of the scholarship will be paid upon notification of the student enrollment number by the Student Office of the Specialization School. The second installment will be paid by **June 30, 2026**, provided that the enrollment number has already been communicated by the student.

<u>Payment orders</u>: The institution will publish any changes to the deadlines specified in the call on the website <u>www.ersusassari.it</u>.

Suspension of payments: Payments will be suspended for students who:

- have not entered their enrollment number online (applicable only to newly enrolled first- and second-level at the University of Sassari);
- have not entered their IBAN code;
- have not entered their certified email address (PEC);
- have entered online the IBAN code relating to a bank or postal account not registered in the name of the student receiving the scholarship;
- have ongoing investigations and/or are admitted with reservations.

Art. 14 - Grounds for exclusion

- The right to the benefits granted by the Institution will be forfeited in the event of withdrawal from studies, transfer to another university during the same academic year (if before **July 30, 2026**), failure to enroll at the university, or if the student is subject to disciplinary sanctions more severe than a warning.
- A student who changes or transfers degree Course after submitting the scholarship application and, as a result of this
 change or transfer, does not obtain the validation of a sufficient number of credits to maintain the benefit, will forfeit
 the scholarship. If any funds have already been received or services used, the student must return the benefit received.
- A student who has received a semester-based scholarship and graduates within the extraordinary session of the 2024/2025 academic year will forfeit the benefit due to not meeting the enrollment requirement for the 2025/2026 academic year. The semester scholarship amount already received will be converted into a Graduation award.
- A student conditionally admitted in the final rankings will automatically forfeit the benefit if the required supporting documents are not submitted within the deadlines specified in the call.

















- The scholarship is compatible with student collaboration scholarships, scholarships for participation in international
 mobility programs (e.g., ERASMUS scholarships), and/or other benefits for purposes other than supporting the right
 to education, provided by other public and private institutions. Students eligible for multiple forms of assistance are
 required to exercise this option (Article 24 of Regional Law 37/87).
- Students who owe debts to ERSU cannot submit an application for this call, unless they settle the debt within the deadlines for review requests.
- Students who owe debts to the Region of Sardinia or its instrumental bodies, as provided for in Article 14 of Regional Law no. 5/2016, cannot submit an application for this call, unless they settle the debt within the deadlines for review requests.
- Failure to submit the ISEE for the right to university education or the Single Substitute Declaration (DSU) within the deadline for review requests will constitute grounds for exclusion.
- The presentation of an ordinary ISEE and/or ISEE for the right to university education containing <u>omissions or discrepancies</u> will also be grounds for exclusion.

Art. 15 - Declaration of Attainment of 20 Credits for First- and Second-Level newly enrolled students. Revocation of benefits

Students enrolled in the first year of bachelor's, single-cycle, and master's degree Courses must declare having earned at least 20 credits by November 30, 2026 (Article 5, paragraph 4 of Ministerial Decree no. 1320 of December 17, 2021). Students who earn 20 credits after August 10 and by November 30, 2026, are entitled to retain the first installment of the scholarship received and related services.

The achievement of the required academic merit **must be declared** online by accessing to the personal page on the ERSU Sassari website (www.ersusassari.it), in the section 'Scholarship – Ranked' → 'Certification of 20 credits'.

Once completed, the certification must be submitted by clicking the designated 'SEND COMMUNICATION' button. Make sure you have received a copy of the submitted certification in the 'RECEIPTS' section of the online service portal.

In case of **revocation**, any amounts received and the value of services actually used must be returned. Upon justified request, repayment may be allowed in installments.

In exceptional, duly documented cases, such as: serious family financial difficulty (e.g., dismissal of a family member), change in family situation (e.g., death of a parent), serious difficulty resulting from illness of the student or another family member, or inability to take exams, not attributable to the student and documented by the University, an extension of up to three months may be granted to achieve the minimum levels of merit required to avoid revocation.

To this end, the student must submit the extension request by 10/12/2026; in this case, the merit requirement must be achieved by 28/02/2027.

The criteria regarding the conditions for the payment of the second installment and the revocation of the benefit do not apply to first-year students with disabilities. (Art. 14, paragraph 7, D.P.C.M. 9 April 2001).

Art. 16 - Classification of students (resident, commuters, non-resident)

For the purpose of awarding the scholarship, students are classified as **resident commuters**, or **non-resident** based on their place of residence in relation to the educational premises they attend.

Students enrolled in courses offered at Sassari premises, but who primarily attend facilities in one of the local branches, will be classified based on the latter.

Pursuant to Article 4, paragraph 8, of the Prime Ministerial Decree of 09/04/2001, the following general classification applies:

resident/resident	a student residing in the municipality or surrounding area of the location where the course is attended.
commuters/pendol ari	a student residing in a location that allows for daily travel to the site of the attended study program, or who does not provide evidence of paid accommodation near that location.

















non-resident/non-residente

A "non-resident" student is one **residing in a location far from the site of the attended course** and, for this reason, demonstrates that they have secured accommodation at their own expense near the course location. This must be proven by a lease agreement or a regularly registered service contract in their name, using public housing facilities or other private accommodations for a period of **no less than 10 months** between **September 1, 2025, and October 31, 2026**.

Non-resident students awarded a **semester-based scholarship** may submit a contract covering a period of **no less than 5 months**.

For students attending the filter semester or an inter-university course, the scholarship increase related to non-resident status will take into account paid accommodation at the course location or nearby, provided that it lasts for a period of at least three months. The increase is calculated based on the number of months actually spent in paid accommodation during the academic year, including any period spent during the filter semester or during the semester attended at another teaching location (inter-university courses).

<u>Independent student:</u> Independent students are awarded the scholarship amount designated for non-resident students, provided they use accommodation subject to a documentable rental cost (Ministerial Decree 1320/2021). <u>International students:</u> International students whose family does not reside in Italy are considered non-resident students regardless of their residence in Italy, except when the student's family unit resides in Italy.

ERASMUS student: Students participating in EU programs (e.g., Erasmus, Double Degree, etc.) must submit a self-certification, by completing the online form provided by the institution, certifying that they have obtained paid accommodation at the ERASMUS (or similar) study locations and in Italy, provided that the period is continuous. The rental period or provision of services must be no less than 10 months, between September 1, 2025, and October 31, 2026.

<u>Final semester student:</u> Students receiving a semester-based scholarship may submit a rental contract for a period of no less than 5 months. Those who graduate by the extraordinary session of 2024/2025 are **NOT** required to provide proof of non resident student status.

<u>Students in detention</u>: They are always considered as resident students unless they benefit from semi-liberty measures, in which case the institution reserves the right to assess individual cases based on additional documentation provided by the relevant prison authority.

Out-of-Residence Status

Out-of residence students from December 1, 2025, and no later than March 31, 2026, at 1:00 PM are required to confirm their status by self-certifying through the online procedure a rental contract or service contract duly registered in their name, including the details of the landlord/service provider, the location of the accommodation, the rent amount, and the duration of the contract, which must be no less than 10 consecutive months; no extra benefits (e.g., reimbursement for the so called Fitto Casa) should have been received for the same contract.

In the event of failure to certify the out-of-residence status or it has been certified after the deadline, ERSU will proceed to reclassify the student status from "out-of-residence" to "commuter" with a consequent adjustment of the amount of the scholarship due when the second instalment of the scholarship is paid.

Please note that students belonging to households that own residential properties in the location of the course attended will be considered COMMUTERS, resulting in a corresponding adjustment to the second installment payment.

ERSU will conduct the appropriate checks as outlined in Article 20 of this announcement.

Article 17 - Provisions for students with disabilities (Article 14 of D.P.C.M. 9 April 2001)

Use and duration of benefits

The duration of the granting of benefits for students with disabilities is:

- nine semesters for Bachelor Courses;
- thirteen semesters for Single-cycle Courses (five-year duration);
- fifteen semesters for Single-cycle Courses (Six-year duration);
- Seven semesters for Master Courses (2nd level).

The housing benefit has been increased for an additional semester.

The merit criteria for payment of the second instalment and revocation of the benefit, as outlined in Articles 13 and 15 of the call, do not apply to students enrolled in their first year.

Graduation award

Students who graduate within the first year outside of their prescribed timeframe (supplementary year) are entitled, subject to the Institution's financial resources, to a scholarship supplement equal to half the amount received in the first year outside of their prescribed timeframe. Students must submit their application according to the procedures outlined in Article 6 of this call.

Funding and Criteria for the formulation of the ranking

The total funding of €776,501.65, defined according to the methods outlined in Article 9, will then be divided by assigning 30% of the allocation to students who enroll for the first time (€232.950,50) and 70% to students enrolling to subsequent years (€553,551.16). Two rankings will be drawn up:

- For first-year students, a single ranking will be drawn up, taking into account the percentage of disability first; in the event of a tie, the Equivalent Economic Situation Indicator (ISEE) of the student's family unit will be taken into account in ascending order, and then the oldest student will be considered;
- For students enrolled in subsequent years, a single ranking will be drawn up, taking into account the percentage of
 disability first. In the event of a tie, the ratio between the student's merit and the number of credits earned will be
 taken into account, at a rate of 60 for each year attended. The denominator is increased by 10 credits for the second
 year outside the prescribed timeframe and by 15 credits for the third year outside the prescribed timeframe. In the

















event of a further tie, the average exam scores will be taken into account, followed by the ISEE of the family unit, and finally, the oldest student.

The students referred to in this article are exempted from paying the Regional Tax.



The disabled rankings will be available exclusively to the students by accessing their personal area on the website of the Institution at www.ersusassari.it

Please note that students must submit documentation as per Article 11 of this announcement, attaching, in addition to the documentation required in the aforementioned article, a copy of the disability certification.

Scholarship amounts awarded for the 2025/2026 academic year will be increased as follows:

- 40% increase for students with a certified disability percentage greater than 80%;

Accommodation for first-year students is further divided into 1st, 2nd, and 3rd level categories based on the percentage of eligible applicants in the final rankings.

Accommodation for students enrolled in subsequent years is further divided by Degree Course year based on the percentage weight of eligible applicants in the final rankings.

Students who apply for accommodation and scholarships and subsequently wish to withdraw from accommodation must submit their revocation by the deadline for requests for reconsideration of provisional rankings.

In the event of a subsequent revocation (after the deadline), the scholarship amount assigned in the final ranking will remain unchanged.

Accommodation Fees

The accommodation fee is defined as follows:

• Scholarship beneficiary and Accommodation beneficiary

The scholarship amount will be paid net of housing costs (with deductions for the service itself, amounting to €1.993,46 for ten months of use).

Eligible but non-beneficiary for the scholarship and accommodation beneficiary

The amount of housing fees is defined as follows, based on the income bracket:

First Bracket: ISEE up to two-thirds of the income threshold:

Monthly rate for a single room: €82,00 Monthly rate for a double room: €61,34

Second bracket: ISEE between two-thirds of the income threshold and the reference limit:

Monthly rate for a single room: €97,51 Monthly rate for a double room: €77,87

Should students subsequently become scholarship beneficiaries, they will be paid the scholarship amount net of accommodation costs, less any amounts already paid in previous months based on their income bracket.

• Scholarship beneficiary and eligible but non-beneficiary for accommodation:

The scholarship amount will be paid gross of the housing fee (excluding any deductions for the service itself). If students subsequently receive accommodation, the value of the housing fee, calculated at €199,35 per month, will be deducted from the scholarship amount, including the cash value of the bed, regardless of the room type.

Eligible but non-beneficiary for the scholarship and Eligible but non-beneficiary for housing:

If students subsequently become eligible for housing, the amount of the accommodation fees will be determined based on their income bracket.

If students subsequently become eligible for a scholarship, the amount of the scholarship, including the cash value of the accommodation, will be deducted from the cost of the housing service, calculated at €199,35 per month (regardless of room type). This amount will be calculated from the day the accommodation is assigned and reduced by the amounts already paid based on their income bracket.

Accommodation beneficiary students must pay, based on accommodation regulations, a deposit of €150.00 to cover any damages.

Assignment method

Upon publication of the final rankings of housing service, students who have been successful or eligible must provide acceptance, filling in the online procedures that will be activated at the same time, in the manner and within the deadlines indicated in the following paragraphs.

















In the following days, students will receive an email from noreply@ersusassari.it with the details of the room assigned, including the destination residence and the period of access.

Winners: Online acceptance

Students who are successful in the final housing service rankings must accept their accommodation through the specific procedure, called "Acceptance," available by accessing the housing service rankings from their personal page on the ERSU Sassari Online Platform. The acceptance form must be completed and submitted exclusively online according to the deadlines indicated in the following table.

When filling out the acceptance form, you must select one of the following options:

- I accept;
- I accept (Erasmus Option) (see paragraph International Students);
- I refuse

In the online acceptance the student must put in order of preference all the residences of the ERSU of Sassari listed in the procedure. The option of choice is not guaranteed for the local branches, where the assignment of the bed can be carried out directly by ERSU in order to optimize the occupancy of the available places.

In the case of the "Erasmus Option" (for stays abroad of less than 8 months), the period of stay abroad must also be indicated, specifying the departure and return dates, which must be between 8 October 2025 and 31 July 2026.

You will also need to complete all additional fields in the procedure, if they are not already pre-filled (personal details, residence permit, or residence permit application receipt), and read and accept the relevant information, which is necessary for the subsequent assignment of a bed.

The online acceptance is considered correctly completed and submitted if and only if a receipt is sent to the student's email address with a PDF of the completed form attached. The receipt is also available on the student's personal page at the ERSU Sassari Online Platform, in the "Receipts" section.

N.B. The system does not allow changes to submitted data, so students are encouraged to check that the form has been filled out correctly before submitting it.

If the student fails to complete and submit the online acceptance form by the deadline, they will be placed at the bottom of the final ranking for accommodation provision. Consequently, they will not lose their right to use the accommodation, but will be called (if they express interest) to choose a place after all successful students, before eligible but non-beneficiaries are called.

The same procedure will apply to students who turn down a position during the online application process.

It is understood that failure to turn down the accommodation offered within the deadlines outlined in this announcement will, in any case, result in the withholding tax outlined in Article 10 of the announcement (€1.933,46).

Eligible but non-beneficiaries: acceptance by declaration of interest

Students who are eligible in the final accommodation rankings must declare their interest in obtaining a place in the ERSU Sassari residences by completing and submitting the specific online procedure, called "Acceptance," available by accessing the housing service rankings from their personal page at the Online Platform, according to the deadlines indicated in the following table.

When completing the declaration of interest, they must select one of the following options:

In the online acceptance, students must rank all ERSU Sassari residences listed in the application. Choice is not guaranteed for local branches, for which accommodations may be automatically assigned to optimise occupancy. Eligible but non-beneficiary students will be assigned accommodations in residences where there are still vacancies after the beneficiary students have been accepted.

Before submitting the application online, students must also complete all additional fields in the application process, if they are not already pre-filled (personal details, residence permit, or residence permit application receipt), and read and accept the relevant information, which is necessary for the subsequent assignment of accommodation.

The declaration of interest is considered correctly completed and submitted if and only if a receipt is sent to the student's email address. The receipt is also available on the student's personal page at the ERSU Sassari Online Platform, in the "Receipts" section.

N.B. The system does not allow changes to submitted data, so students are encouraged to check that the form is correctly filled in before submitting it.

If the student fails to complete and submit the online acceptance form by the deadline, they will be placed at the bottom of the list of eligible non-beneficiary students in the final housing services ranking. Consequently, the student will not lose the right to use the housing service, but will be asked (if interested) to choose a place after all eligible but non-beneficiary students.

The same procedure will apply to students who have declined accommodation during the online application process. It is understood that failure to turn down accommodation within the deadlines outlined in this announcement will, in any case, result in the withholding tax outlined in Article 10 of the announcement (€1.993,46).

Scholarship-receiving students with deduction for accommodation (€1.993,46) who, for any reason, do not occupy a room (for example, by refusing the accommodation after the deadline or by failing to accept it through the appropriate online procedure), who express interest in using the accommodation during the year (after all rankings have been processed), may apply at any time. In this case, they will compete with all other students (without scholarship) who requested paid accommodation.

If there is still available money and the request is accepted, the student will be able to use the accommodation service without further payment (since the accommodation service fee has already been deducted from the scholarship amount).

International Students

Only students on international mobility (Erasmus) for a period of less than 8 months are entitled to accommodation. In this case, students assigned housing at an ERSU Sassari residence must accept the accommodation with the Erasmus Option.

- Upon acceptance, students must indicate the precise period of their stay abroad, starting from October 8, 2025.
- 2. After acceptance, as soon as all the necessary documents are in possession, the student must send an email to alloggi@ersusassari.it
 - a. a copy of the document issued by the international mobility offices of the student's university, certifying the details of the mobility project;
 - b. acceptance letter from the hosting foreign university;

















c. a copy of the front and back of a valid identity document.

If the accommodation is assigned during the academic year, this documentation must be submitted upon acceptance. Guests of an ERSU Sassari residence who win an international mobility project after acceptance during the academic year must send an email to alloggi@ersusassari.it at least 7 days before departure:

- 1. The text must include student's personal details, the accommodation that has been assigned, and the type of international mobility project;
- 2. The following must be attached:
 - a copy of the document issued by the international mobility offices of student's university, certifying the details of the mobility project;
 - b. After departure, acceptance letter from the host foreign university.

The return date and repossession of the room must be communicated to the same email address at least 10 days in advance.

Students participating in mobility programs who, following extensions, exceed a mobility period of more than 8 months must present the document issued by the University certifying the extension. It is understood that for periods of absence exceeding 8 months, they will be granted access to the accommodation only if there are available places.

Assignment of a bed at the ERSU Sassari Residences

The assignment of a bed consists of the right to use one of the places available for competition, not a place chosen by the student.

Assignment criteria

Bed assignments are made based on the ranking and the order of residence preference indicated upon acceptance. After the winners have been assigned, the assignment of eligible but non-beneficiaries is carried out using the same procedure.

Interested parties will receive an email from noreply@ersusassari.it with the details of the assignment and with indication of the destination residence and the period of entry.

Students who refuse at the time of assignment, or do not show up in residence on the dates indicated in the assignment email, lose the right guaranteed to them by the position in the ranking, without prejudice to the above described (passage in the queue to the ranking of winners or eligible non-beneficiaries or possibly called to compete together with students without scholarship requirements).

Room type

The assignment of the room takes place in order of ranking, **compatibly with the available places**. The first year students from different types of course levels are intended for double rooms.

Assignment procedures

Students who have accepted a bed will receive an email from noreply@ersusassari.it with all the details regarding their assignment.

The right to use the accommodation begins from the date of possession until **July 31, 2026**, excluding the Christmas holidays. Rooms must be vacated by **December 23, 2025**, and the residence hall will be open again starting **January 7, 2026** (check-in and check-out times will be announced on the institutional website).

The Institution reserves the right to keep one or more accommodations (apartments or residences) open during the Christmas period to meet the needs of foreign students or non-residents of Sardinia who are unable to return to their countries of origin or to their residence.

N.B.: Students who are in debt or fail to comply with the provisions of the Institution's Accommodation Regulations will not be assigned accommodation for the 2025/2026 academic year.

Filter Semester Students

Students with the status of "concurrently enrolled student" pursuant to Article 3 of Ministerial Decree No. 418/2025 may

















benefit from the housing service at the discounted rate provided for in this announcement for eligible students who are not scholarship recipients and who are eligible for first-tier housing (€82.00 for a single room and €61.34 for a double room), provided that the filter semester consists of at least 51% in-person teaching activities.

These students will be able to benefit from the housing service (starting from the assignment dates established for all students) for a period of time to be subsequently established by the Institution, in relation to the publication of the national ranking pursuant to Article 7 of Decree No. 418 of the Minister of Universities and Research of May 30, 2025. Furthermore, no. 10 places are available for first-year students in the Single-cycle degree programs in Medicine and Surgery LM-41, Dentistry and Dental Prosthetics LM-46, and Medicine and Veterinary Medicine LM-42, who submit an application for benefits following enrollment in the second semester of the 2025/2026 academic year, at the end of the "filter semester," during the additional time window provided for in these Guidelines, in accordance with the provisions of Regional Council Resolution No. 38-14 of 16/07/2025 for the allocations to be set aside for these same students.

The right to benefits is revoked if, upon verification of the authenticity of the self-certifications provided, the student is found not to meet the merit and income requirements.

Art. 19 - Transfers from other universities (request for transfer of scholarship application)

Students transferring from one university to another before **September 8, 2025**, must submit an application to the Right to Education Institution of the university to which the transfer was requested.

If transferring from the University of Sassari to another university after September 8, 2025, the application already submitted to the ERSU of Sassari will be forwarded, upon request, to the relevant institution, based on the procedures established in the call for applications by the relevant Right to Education Institution.

After transferring, the student will lose the right to benefits provided by the ERSU of Sassari.

Students from other universities will be admitted to the competition according to the criteria established in this announcement only if they have submitted their scholarship application to the Right to Education Institution and the documentation is received by ERSU Sassari by **September 28**, **2025**.

In this case, the student may apply for the benefit only if they have not previously received it for the same year, unless they have renounced the scholarship and returned it to the Right to Education Institution of their home university.

Art. 20 - Verification of self-certifications

All data entered in the scholarship application is provided according to Articles 46 and 47 of Presidential Decree 445/2000 and may be subject to verification at any time according to Article 71 of the same Presidential Decree 445/2000.

The ERSU verifies the authenticity of the self-certifications submitted, signed, and produced by students, including through random checks.

ERSU also initiates specific verification procedures in the event of reports.

All students with "independent student" status and all first-year students will also be subject to specific verification regarding their achievement of the 20 credits required for the disbursement of the second instalment of the scholarship. In carrying out these checks, ERSU may request appropriate documentation to demonstrate the completeness and accuracy of the data declared.

The right to benefits is revoked if, upon verification of the authenticity of the self-certifications provided, the student is found not to meet the merit and income requirements.

The benefit is also revoked for students who, based on the self-certification provided, are included in the eligible first-year ranking but are regularly enrolled in a course of study in subsequent years.

Verification of income and asset data declared by beneficiaries of the interventions is required through direct access to the Local Authorities Tax Registry Exchange System (SIATEL) of the Revenue Agency, according to Article 10, paragraph 1 of Legislative Decree No. 68 of March 29, 2012.

Merit-related data are subject to certification by the university of origin as well as verification through direct access to the Esse 3 University registry. ERSU will, at any time, verify the self-certifications produced by students who have been awarded the benefit, following Article 71 of Presidential Decree 445/2000, and will send the data of the aforementioned students to the competent Financial Offices, to allow the offices themselves to carry out further checks on the actual consistency of the family income (Article 10, paragraph 2, Legislative Decree 29 March 2012, no. 68).

Should a student submit an untrue statement in order to benefit from the benefits of this call, he or she will be subject

















to an administrative penalty consisting of the payment of a sum three times the amount received, or the value of the services improperly used, and will lose the right to access the benefits of the Institution for the duration of the course of study. This is without prejudice to the application of the penalties outlined in Article 38, paragraph 3 of Legislative Decree no. 78/2010 converted into Law 122/2010, as well as the criminal provisions for acts constituting a crime. (Article 10 of Legislative Decree 68/2012).

Art. 21 - Information on Personal Data

Personal data relating to this procedure will be processed based on methods outlined in Art. 13 of EU Regulation 2016/679 attached to this notice.

Art. 22 - Regional Tax and Tuition Fee Exemption

Tuition fees: Any exemption and/or refund of tuition fees is the responsibility of the institution where the student is enrolled (University, Academy, Conservatory, and Higher Institute of Religious Sciences). Upon publication of the final rankings, the ERSU will forward the lists of scholarship recipients and eligible candidates for the 2025/2026 academic year to the relevant offices (University, Academy, Conservatory, and Higher Institute of Religious Sciences).

Students are required to pay the tuition fees and the regional tax for the right to education, according to the methods and amounts established by the universities for the 2025/26 academic year.

Eligible students listed in the scholarship rankings are exempt from paying the regional tax for the right to university education and are entitled to a refund/waiver of university fees and contributions.

Regional Tax

Pending the final rankings, students who have applied for access to the right to education benefits for the filter semester may complete their enrollment without paying the regional tax for the right to university education.

Starting with the 2023/2024 academic year, the <u>Sardinian Revenue Agency</u> (**ASE**) has been appointed to collect/exempt the regional tax for the right to university education.

LEGAL BASIS AND PURPOSE OF PROCESSING

The legal bases and purposes of the processing performed by ERSU Sassari are:

- Fulfilment of a legal obligation vested in the data controller (Article 6, paragraph 1, letter c);
- 2. Necessary fulfilment for the performance of a task carried out in the public interest or in connection with the exercise of public powers (Article 6, paragraph 1, letter e);
- 3. TYPES OF DATA PROCESSED

Common data (name, surname, address, marital status, tax code, IBAN, ISEE (Equivalent Economic Situation Indicator) or Single Substitute Declaration (Equivalent Economic Situation Indicator), ISPE (Equivalent Economic Situation Indicator), educational data, contracts).

Data belonging to special categories (health data).

PROCESSING METHODS

Personal data is processed in a manner that guarantees its security and confidentiality, using appropriate paper, computer, and electronic tools and means, adopting technical and administrative security measures to reduce the risk of loss, misuse, unauthorised access, disclosure, and tampering. The data will be processed by personnel specifically designated and authorised for this purpose, identified and specifically trained, in compliance with the principles of relevance, non-excessiveness, and indispensability, solely for the aforementioned purposes.

Provision of data is mandatory, and any refusal to provide it will make it impossible to provide the requested service.

DATA COMMUNICATION AND DISSEMINATION

Personal data is intended and processed by Ersu Sassari for the purposes set out above and will be disclosed to third parties as required by law, to pursue institutional objectives, or as a result of agreements between Ersu Sassari and such third parties. The data may also be published pursuant to Legislative Decree no. 33/2013, as well as on regional portals. The complete rankings, including merit data and financial and asset indicators, will be made available in the student's reserved area on the website: www.ersusassari.it, as well as in the interested party's personal area. The interested party can check their data and ranking position by logging in with their credentials.

















The data provided is provided according to and for Articles 46 and 47 of Presidential Decree no. 445/2000. It may be subject to checks according to Article 71 of the aforementioned law and, to this end, may be disclosed to the Revenue Agency, the Tax Registry, banks, universities, the Autonomous Region of Sardinia, as well as other Italian regions and other bodies for the formal and substantive checks mentioned above.

DATA RETENTION PERIOD

The processed data will be retained for the period of time required to achieve the purposes and, in any case, no longer than the retention period for administrative records, except for any permanent retention for archival purposes, as well as for different periods set forth in the document retention schedule adopted by the Organisation.

DATA TRANSFER

Ersu Sassari does not generally transfer data to countries outside the EU. However, this may occur to fulfil a legal obligation or a contractual obligation. In this case, the transfer will be carried out in full compliance with the law, with a preliminary assessment of whether the recipient country offers an adequate level of personal data protection. In the absence of such a requirement, the Data Controller or the Data Processor will implement the safeguards to protect the data subject as required by Article 46 of the GDPR, and the relevant information will be provided to disclose the methods of data processing.

DATA SUBJECT RIGHTS

The data subject has the rights specified in Articles 15 to 21 of the GDPR, as follows:

- **Right to access personal data**, i.e., to know whether or not personal data is being processed, for what purposes, and for what types of data, as well as the recipients and how long the data will be retained (Article 15);
- **Right to rectification**, or the right to obtain, without undue delay, the rectification of inaccurate data from the Data Controller (Article 16);
- **Right to erasure** ("right to be forgotten"), or the right to obtain from the Data Controller the erasure of personal data concerning him or her without undue delay for the reasons set out in the relevant GDPR provision, specifically including the right to withdraw consent (Article 17).
- **Right to limit processing** in the event of contesting the accuracy of the data, objecting to the processing of the data in the event of unlawful processing, use to exercise rights in court and contextually non-necessity for the processing by the data controller and, finally, pending the verification of the prevalence of the legitimate interests of the data controller over those of the interested party (art. 18);
